## **INFORMATION**

- 1. Total 180622 number of candidates appeared for total 9171 ( 6662 posts of Constables (AB/UB) including post reserved for Home Guards, VDPs, SPOs(Special Police Officers), Sports Persons & FMMOs(Former Member of Militant Organisations), 813 posts of Constables in APRO & 788 posts ( Communication/Messenger/Carpenter/ UB ) in APRO & 788 Constables etc (Sub-Officer/Firemen & Emergency Rescuers) in F&E.S, 754 posts of Constable/Guardsman under DGCD and 154 posts of Constables in AISF [from SPOs(Special Police Officers) only] under DGCD & CGHG.
- 2. PET measurements in the form of RFID chip reading for 3.2km/1.6km and laser reading for long jump alongwith marks of Candidates have been maintained in database including all the Physical Standard Test (PST). These all are maintained properly in digital format.
- 3. Video footages of the events in addition to above records are also available for each category of event. We have complete database of each candidate and their application, performance and marks obtained in the events thereof.
- 4. Results have been declared as per methodologies which are followed in respect of reputed National Level competitive exams.
- 5. As a matter of principle, candidates equalling upto total five times number of posts in each category such as UR, OBC/MOBC, SC,ST etc have been called for written exam. For reasons like--many thousand candidates appearing and clearing cut-off in both AB-UB stream, reserved category candidates securing more marks than Unreserved Category (UR) cut-off and getting absorbed in UR category for written exam call, and non-availability of candidates in certain categories etc, the total no. of qualified candidates may vary.
- 6. In case of any doubt, candidates will get an opportunity to verify and check the above-mentioned records from the database maintained and also the video footage etc within 45 days from publication of final merit list. However, this will be on payment of an amount to be fixed by SLPRB in due course.
- 7. As per Advertisement No. SLPRB/Rec/Const/(AB&UB)/2018/214 dated25<sup>th</sup> April 2018 State Level merit lists have been prepared for FMMO(Former Member of Militant Organisation), SPO's(Special Police Officers), & Sports persons while Police Station level merit list has been prepared for militancy affected area category. Apart from these categories, merit lists have been prepared at district level. So, there could be variations in cut-off marks District to District in various categories.
- 8. SLPRB has opted for a PS wise assessment of merit of candidates under the militancy affected area as per Govt. OM No HMA.155/2012/Pt-II/313.dated 26/03/2018. The name and total no of PSs have been specified and have also been published in Advertisement No. SLPRB/Rec/Const/(AB&UB)/2018/214 dated 25<sup>th</sup> April 2018.
